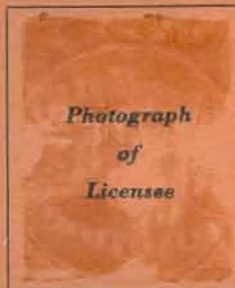

It is valid in every country affiliated with the Federation Aeronautique Internationale. Every contestant or pilot suspended or disqualified by the Association is required to return his license to the Contest Committee, National Aeronautic Association, Washington, D. C., and it cannot be returned to him before the expiration of the period for which his suspension has been declared. All delay occasioned in the return of the license is added to the time of the suspension.
